

HHS Parents and Guardians,

Hagerty High School will begin its state-mandated Resiliency Education Lessons (**REL**), formally known as the Mental Health Lessons, on Monday, October 23, 2023, and Tuesday, October 24, 2023. Lessons will be facilitated through our English-based classes. **The bell schedule will not change, your student will have ½ of their English-based instruction and ½ REL -based lessons during their scheduled English-based class.** There are ten (10), 30-minute lessons in total that will span over the next five (5) months at times and dates indicated below. Your student’s English teacher will facilitate two lessons per scheduled date. If your student does not have an English course, they are still required to complete the state-mandated Resiliency Education Lessons. **There are plans below designated for students who have an HHS English course and for students who do not have an HHS English course.** Please read this whole document with your student.

Clarifying Questions

Question: If my student does not have an HHS-based English course, but has a FLVS or Seminole Virtual English-Based course, does he/she have to participate in the Resiliency Education Lessons?

Answer: *Yes, all active students HHS students (2,400+) must participate in the state-mandated REL lessons. There is a place, date, and time for ALL Hagerty students to participate. Please review: 'Schedules for students with an HHS English-based class or Schedules for HHS students without an English-based class'.*

Question: My student does not have an English-based course. Will they receive this opportunity to participate? What should they do?

Answer: *An email will be sent out to you, your student, and their non-English-based 3rd or 4th-period instructor which will indicate where they are to report during 3rd or 4th period! Teachers and students will be notified when it is time to report to their designated location.*

Question: Will my student who does not have an English-based class be excused during their non-English class when they are participating in the REL lesson modules? Will my child be marked absent?

Answer: *Students who do not have an English class will be marked as 'V', which is indicated as 'School Activity' in Skyward. They will sign in at their designated locations to receive completion during each date they are to attend.*
