

HAGERTY HIGH SCHOOL
STUDENT PARKING INFORMATION and APPLICATION 2023-2024

Student parking passes for the 2023-2024 school year will be sold on the following dates:

Seniors: June 12th – 14th , 2023 eCampus Page – Hagerty Class of 2024 – 300 Passes
Juniors: June 19th – 21st , 2023 eCampus Page – Hagerty Class of 2025 – 175 Passes

Pass sales will begin at 12:00 PM on each designated start date. Only those students in the respective grade levels will be permitted to purchase a pass during their class's designated window.

****Any student with a current permit that will obtain their Driver License on or before September 30th, 2023 may purchase a parking pass in the appropriate submission windows.***

Confirmation emails will be sent via the school email system to individual SCPS accounts by Friday, June 23rd (Seniors) and Friday, June 30th (Juniors).

Seniors and Juniors that did not obtain a parking pass on these dates will have an opportunity to attempt to purchase a parking pass in August during a second window of sales, ***provided that any remaining spaces are available.***

Dual Enrollment, Off-campus Virtual School, OJT, Athletics, Transfers, Controlled Open Enrollments and Extra-Curricular Activities DO NOT GUARANTEE you a parking pass on campus. If you are relying on any of these options to obtain a pass you may want to consider other transportation methods for the upcoming school year.

Passes will be available for pickup prior to the start of the 2023-2024 school year.

General Parking Rules – Initial each listed item.

- ____ 1. ALL DEBTS AND OBLIGATIONS MUST BE CLEARED WITH THE BOOKKEEPER PRIOR TO OBTAINING A PARKING PASS.
- ____ 2. If at any time during the school year you are placed on the obligation list, your pass will be suspended until the obligation has been cleared.
- ____ 3. Parking passes may be revoked pending discipline issues, driving behavior, and student code of conduct issues.
 - * Students are not permitted to leave school for lunch – except for scheduled designated days.
 - * Students going to their car during school days must get a car pass via the front office.
- ____ 4. All vehicles must have a school issued permit/tag to park on campus.
- ____ 5. Students must park in their designated COLOR area on campus.
- ____ 6. Vehicles not parked in their designated locations will be issued a warning sticker, then booted, then towed.
- ____ 7. Cost of the parking pass is \$80, payment though **MySchoolBucks**.
- ____ 8. To obtain a parking pass/tag, students must provide all the following documents in a **SINGLE SCAN PDF FILE**.
 - * Valid Driver License / Permit (Copy)
 - * Vehicle Registration (Copy)
 - * Parking Pass Application – 3 Pages
 - * Insurance Documentation (Copy)
- ____ 9. All tags must be displayed on the rearview mirror of the vehicle or the dashboard.
- ____ 10. Lost or stolen tags or any vehicle changes must be reported to 7-100 immediately.
- ____ 11. Replacement tags will be subject to a fee of \$20.00.

- _____12. Students may share a parking space but must have documentation for both drivers and vehicles on file.
- _____13. Hagerty High School is NOT responsible for any damages to vehicles or personal property.
- _____14. Students may not park in any other area on campus except for their designated location.
- _____15. Students leaving campus without authorization may have their parking pass revoked and face disciplinary action.
- _____16. Speed limit on campus is 5 MPH.
- _____17. Students must exit their vehicle and the parking lot area immediately upon arriving to school.
- _____18. Duplication of a parking tag will result in the loss of your parking privileges for the remainder of the year, along with the appropriate school discipline.
- _____19. **Vehicles parked on campus are subject to search at any time.**

There is a possibility that your parking area may be changed due to any schedule changes during the year.*
